

This User agreement defines the terms of use of materials and services of the sites https://www.easylab.agency, https://www.easylab.network, and also represents an offer (public offer) to conclude a contract under the terms hereunder:

Using of materials and services of the Site is regulated by the current legislation of the Russian Federation

Using the Service in any way and in any form within its declared functionality, including:
